01 - THE CHALLENGE

Implementing an Ariba or SAP contract management solution can integrate many upstream and downstream procurement functions, removing time and costs, reducing errors, and increasing spend under management. The first challenge is to just find all your vendor contracts, but then the second is to extract all the metadata. One solution can be to do manual reviews of contracts to extract the data and then load it into SAP Ariba, but that can take many months and significant amounts of money.

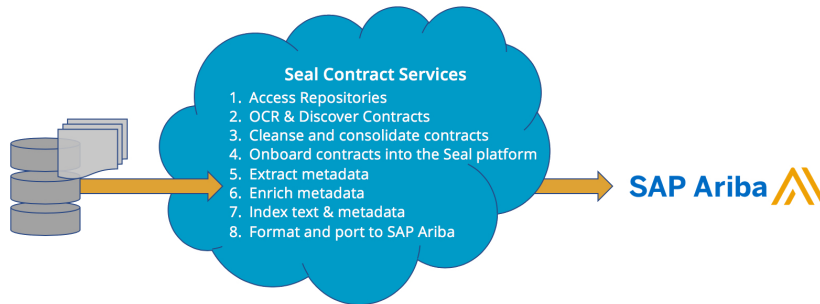
